To ensure compliance with the Beacon Safety Protocol, Beacon Promotions requires that its products demonstrate - via testing by an independent analytical laboratory - that they comply with both the California Proposition 65 exposure standard as well as the Federal Consumer Product Safety Commission's toughest requirements. Through our vigorous enforcement of the Beacon Safety Protocol™, Beacon Promotions pledges to ensure compliance with California's Proposition 65 as well as all relevant national safety standards to protect our customers.

Safety sheets and supporting documentations are readily available for all products upon request. As part of our rigorous quality program, we keep and maintain detailed quality records throughout our entire supply chain. This starts with inspections at our oversea factory by qualified audit team in China. We also set up third-party factory audits for both social and quality compliance on a regular basis. At least on a biannual basis, The Beacon Promotions team from the United States conduct on site audit of our supplier factory to ensure and maintain the highest level of quality and safety for our product.
